Legal basis	<ul style="list-style-type: none">• Art. 6 Abs. 1 lit. a GDPR – consent• Art. 6 Abs. 1 lit. b GDPR – (pre)-contractual measures• Art. 6 Abs. 1 lit. f GDPR – Lawfulness of processing (legitimate interest) <p>The processing of the personal data provided by you is necessary for the fulfilment of contractual obligations arising from the contract concluded with us.</p> <p>Data processing for other purposes can only be considered if the necessary legal requirements pursuant to Art. 6 para. 4 GDPR are met. Any obligations to provide information pursuant to Art. 13 para. 3 GDPR and Art. 14 para. 4 GDPR will of course be observed in this case.</p>
Storage period	<p>The deletion periods are based on the legal requirements. You can revoke your consent pursuant to Art. 6, para. 1, lit. a, GDPR at any time by contacting the controller.</p> <p>You may at any time (and without giving reasons) terminate the contract concluded with FIR e. V. an der RWTH Aachen (with effect for the future), concerning the storage of your personal data, which we collect while downloading a document and pass on to the named partners. Upon receipt of your notice of termination, it will take effect immediately. The FIR e. V. an der RWTH Aachen reserves the right to then cancel the contract concluded with you and not to perform the service.</p>
Automated decision making and profiling	<p>As a responsible company, we do not use automatic decision-making or profiling when collecting your personal data.</p>
Recipients of the personal data outside the company / authority / third country	<p>Your data will be transmitted to the partners mentioned in "terms and conditions for this download" for advertising purposes.</p> <p>No further transmission of data will take place.</p>
Right to information	<p>You have the right to information about the personal data we process about you. In the case of a request for information that is not made in writing, we ask for your understanding that we may then require evidence from you that proves that you are the person you claim to be.</p>
Right to rectification	<p>Furthermore, you have a right to rectification, i.e. you can demand that we correct your incorrect personal data without delay. Taking into account the purposes of the processing, you have the right to request the completion of incomplete personal data - also by means of a supplementary declaration.</p>
Right to erasure	<p>You have the right to request that we erase your data immediately.</p>

Right to restriction of processing	You have the right to request the restriction of processing.
Right to object to processing	In particular, you have the right to object to the processing of your data in connection with a direct advertising if this is carried out on the basis of a balancing of interests. To do so, please contact the controller of the processing.
Right to data portability	You have the right to obtain the data you have provided in a structured, common and machine-readable format from the controller. We must not hinder a transfer to another controller.
Right to log a complaint with the competent supervisory authority	You can lodge a complaint with a supervisory authority (Art. 77 GDPR).
